- Superintendent Dr. Jane Eichman presented an overview of the 2017-2018 school year to the School Board. In addition to expected retirements and anticipated personnel needs, other subject areas specifically addressed included projected enrollment figures, school district programs, classroom space, welding and dual credit classes through John Wood Community College, and the installation of a new telephone system.
- Superintendent Dr. Jane Eichman updated School Board Members on Senate Bill 550, a law signed by Governor Rauner. The law requires schools to test for lead in drinking water in K-5 buildings from any source or outlet where non-bottled water is ingested by children or used in food preparation.
